The organization was able to increase youth willingness to engage with the organization's team of screened, trained and compassionate personnel via various means of technology and assembly. In 2017, the organization had 60,235 chat conversations with 16,439 clients averaging 37 minutes in length. They also hosted, through their Get Schooled Tour Assembly Program, 46 school convocations, during which they encouraged over 25,000 students to share their secret struggle with a trusted adult and move into a system of care.
